CLASS REQUIREMENTS:

- Students must provide your own equestrian helmet. Children 17 and under are required by law to wear a helmet while riding a horse. Closes toed boots with a low heel are required. Please no steel-toed boots, soft-shell or rain boots; these are a safety hazard.
- If the student(s) arrive fifteen (15) minutes or later to the start of class, student(s) will not be able to ride that day and are not eligible for refund or makeup. Liberty Stables allocates the first twenty minutes for grooming, tacking and equine equipment education: late arrival will hold up the rest of the group.

TERMS & CONDITIONS

For all sessions, payment in full is required to hold your spot. If you are unable to participate in the class, a credit of \$215 will granted for services at Liberty Stables. Please note: As with our other lesson programs, if you cannot make it to a lesson there will NOT be make ups available. Also, on occasion – we do need to cancel a lesson due to weather i.e. snow storms or tornado warnings. If we have more than one cancellation, we will schedule a make-up lesson! ** Each class must have at least 4 students enrolled in order for us to hold the class – however, this has not been a problem in the past, as our classes tend to fill up fast. Those enrolled in a class that does not make will be give the opportunity to transfer into another time slot/session.

Liberty Stables Release and Indemnification Agreement

This Release and Indemnification Agreement dated ____ day of _____, 201____ is by and between Liberty Stables and Mandy Thomas (Mandy), and _____, (Guest).

Whereas, in exchange for Property Owner's and/or Liberty Stables and Mandy agreement to allow Guest to ride/board/train/trail/haul horses owned by Property Owner or horse owned by others and engage in other recreational activities upon the land or property leased or used by Mandy or Liberty Stables provided that Guest agrees to release Mandy/Liberty Stables/Property Owner from any claims Guest has or may have in the future against property damage, or theft and to indemnify Mandy/Liberty Stables/Property Owner for any claims arising out of any Guest's activities.

Now, Therefore, in consideration of the foregoing premises, it is hereby agreed to by and between Mandy/Liberty Stables/Property owner and Guest as follows:

1. Guest hereby acknowledges and agrees that the activities which Guest plans to engage in are or may be dangerous and may involve risks of injury or death, and/or property damage, and that Mandy/Liberty Stables/Property Owner assumes NO responsibility for such activities.
2. In recognition of the fact that Guest is voluntarily engaging in activities which are potentially dangerous/deadly and that Mandy/Liberty Stables/Property Owner has no control over the activities, Guest, for him or herself, his or heirs, successors, assigns, personal representatives and forever discharge Mandy/Liberty Stables/Property Owner, including Mandy's/Liberty Stable's/Property Owner's his or heirs, successors assigns, personal representative and next of kin of and from any and all claims, demands, allegations, actions, causes of action and all other liabilities of any nature whatsoever, whether in law, equity or otherwise, and whether or not presently known that Guest had, has or may have in the future against Mandy/Liberty Stables/Property Owner arising out of or based on any aspect of Guest's use of real property or personal property, including horses.
3. Guest will defend Mandy/Liberty Stables/Property Owner against any and all claims brought or filed against Mandy/Liberty Stables/Property Owner with any respect to any liability arising from Guest's use of Mandy/Property Owners/Liberty Stables real or personal property.
4. By signing this, you give us permission to call 911 in case of an emergency.

***Notice: A person who is engaged for compensation in the rental or equines or equine equipment or tack or in the instruction of a person in the riding of driving of an equine or in being a passenger upon an equine is not liable for the injury or death or a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481(1) (e) of the Wisconsin State Statutes.
