Please read and initial each item below:

___1. I understand that the deposit made for horse show above is non-refundable. Canceled shows or trainer cancellations will result in a credit of funds to your account at Liberty Stables.

___2. I understand that I am responsible for filling out all show forms, paying for stalls, purchasing shavings, and paying my own class and office fees for myself/my student.

___3. I understand that I am responsible for the behavior of myself and/or student at all times.

___4. I understand that I and/or student must listen and obey all staff of Liberty Stables.

___5. I understand that I and/or my student must care for our own horse (regardless if owned by Liberty Stables) before, during and after the show. This includes wrapping legs for transport, preparing hay bags for transport, offering horses water throughout the day, and ensuring the horse is comfortable.

___6. I understand that I and/or student is responsible for loading our own horse (regardless if owned by Liberty Stables) into and off of the trailer. This applies to both going to the show and returning.

___7. I understand that I and/or my student am responsible for cleaning out the trailer when we return to Liberty Stables.

___8. I understand that if I borrow property of Liberty Stables, that it must be returned in the same condition. Damaged items will result in a replacement fee.

___9. I understand that I will be invoiced for all trailering, coaching or any other expenses that arise out of attending this show.

___10. I understand that payment for services and fees will be due no later that 48 hours after invoices have been processed. A late fee of \$10 will be added for each 24 hour period that the payment is late.

___11. I understand that horse owners will responsible for bringing a **current coggins** for the show office.

Horse Shows

Any student who is enrolled in our lesson program and owns or leases a horse may participate in the off-site horse shows Liberty Stables attends. All students are encouraged to participate in on-site mock & fun shows. Upcoming shows will be posted on the website. A \$75 non-refundable deposit is required a minimum of two weeks prior to the show. You may use your own horse and tack or your leased horse and school tack. You are responsible for your own show clothes.

We require a minimum of three horses to attend a show. An assistant may coach shows with 3-4 riders attending. Mandy will coach shows with 5 or more horses. If lack of participants prevents us from attending, your deposit check will be refunded in full. If we have too many interested riders those whose deposit checks were received first will be granted priority.

All riders are responsible for preparing their horse the day before the show. This includes bathing, grooming and clipping. Liberty Stables will haul your horse, but you are responsible for your own transportation the day of the show. You must be present at the barn to load your horse/tack on the trailer, unload at the show, remain with your horse throughout the day, load after the show and unload your horse/tack back at the barn. All participants must assist with trailer, camper and barn clean-up after the show.

After each show, you will receive an invoice for the total for both Liberty Stables services & the show fees, these invoices must be paid within 48 hours. If payment is not received within the 48 hours, a fee of \$10 will be issued for every 24 hours that the invoice remains unpaid.

*** If a parent rides their own horse and shares that horse with their child, it will be assumed that Mandy will not be coaching the parent. But if Mandy feels there is a need to step in to coach for safety of horse and/or rider, a coaching fee will be added to your show bill.

The coaching fee may include: instruction prior to and during the show, administrative duties, and may or may not include show supplies, mane & tail braiding and horse clipping. Liberty Stables does not provide clippers or blades for boarder's horses. The day of the show there are many basic grooming and horse care responsibilities that Liberty Stables cannot be responsible for. A parent or groom will need to accompany all minors and new students for the entire show day.

Trailing Agreement and Liability Release for Liberty Stables

This Trailing Agreement and Liability Release for Liberty Stables ("Agreement") is made and entered into the date of the signature provided below, by and between Liberty Stables and the undersigned owner or other person authorized to enter into this Agreement for trailing the below identified horses (collectively "Owner"). On exchange for reasonable consideration, the receipt of which is hereby acknowledged, Owner agrees as follows:

- 1. Transport:** Owner requested Liberty Stables, the Horse, described as: (Name) _____, color _____, gender _____ ("the Horse") from the Horse's current location to the Owner's requested destination, and return the Horse to Owner's designated location. These terms and conditions of transport supersede all prior documents, verbal agreements, and other prior statements regarding the terms and conditions of transport and can only be modified Liberty Stables written consent.
- 2. Release /Hold Harmless/Indemnification/Liability Limits/Reimbursement:** Liberty Stables shall be responsible only for the actual transporting of the Horse. Owner, on his/her own and on behalf of Owner's Agents (including, but not limited to, individuals assisting in loading, unloading, and/or transportation of the Horse and/or Owner's personal property (collectively "Owner's Agent") hereby releases Liberty Stables, and their respective Managers, Members, Officers, Directors, agents, assigns, trustees, beneficiaries, employees, working students, volunteers, independent contractors, and others acting on their behalf, (collectively "Released Parties") for injuries to or death of the Horse or the damage or loss of property (collectively "Horse and Property Loss) during transport and/or in the loading, unloading, or transporting of the Horse regardless of whether Released Parties assisted in the transport, loading, or unloading. Owner agrees to indemnify Release Parties for Horse and Property Loss and for injury or death to the Horse resulting from negligence or other fault of Released Parties, other than reckless or intentional misconduct. Owner agrees to release and discharge Release Parties from all liability from any cause whatsoever and, in said event, Released Parties shall be liable only to the extent of \$500.00 collectively for Horse and Property Loss and any cost related to or arising out of the delay in the transport of the Horse. Owner agrees Release Parties shall not be responsible for the behavior of the Horse to itself or other another animal such as biting, kicking, goring or smother, or for Horse and Property Loss arising from the condition of the Horse or which results from the Horse's behavior, which risks are assumed by the Owner. Owner agrees to remain solely financially responsible for any damage caused to Liberty Stables' vehicles and trailers resulting from loading, unloading, or transporting, the Horse and to either repair any such damage within 30 calendar days of its occurrence or reimburse Liberty Stables within 30 calendar days of invoice for any such damage repairs made. Owner agrees to reimburse Released Parties for any and all attorneys' fee and cost incurred by them in enforcing this Agreement and/or defending or prosecuting any claims or caused of actions arising out of this Agreement.
- 3. Warranties:** Owner warrants the Horse is in all aspects fit and suitable for the intended transportation and not suffering from any communicable illness or other conditions harmful to itself, persons, or other horses.
- 4. Emergency Authorization:** Liberty Stables, and authorized agent(s), is authorized, but not obligated, to secure veterinary (including such veterinary care as maybe be necessary, in the discretion of Liberty Stables, to protect the life or health of any Horse in Liberty Stables care), blacksmith, transportation, and other services required for the health, well-being and/or other benefits of the Horse. Owner remains responsible for the costs of all such services which shall be timely paid by Owner to the service provider or within thirty (30) days of Liberty Stables invoice as Requested Services. Liberty Stables is authorized to arrange billing of such services directly to the Owner.
- 5. Miscellaneous:** Transportation service will not be preformed where conditions of roadways, streets, alleys or premises over which vehicles must operate are such that, in Liberty Stables' judgment render it impractical or unsafe to operate or navigate. This Agreement shall be construed and enforces in accordance with the laws of the State of Wisconsin. All disputes relating to the interpretation and enforcement of the provisions of the Agreement shall be resolved exclusively by the state court located in Dane County, Wisconsin and Owner hereby submits to the jurisdiction and venue of the Court for such purpose. Owner agrees that any and all claims and/or causes of action, for injury, death, Horse and Property Loss or other claims or losses, against Released Parties, must be brought within one (1) year of the date of the occurrence giving rise to such claim or loss. In the event any part, portion, term, or condition (collectively "terms") of this Agreement is held to be unenforceable, the remaining terms shall nevertheless continue to be valid and enforceable as though the invalid or unenforceable terms had not been included.
- 6. Certification:** Owner certifies that he/she is the legal owner of the Horse or has the authority to enter into this Agreement for the transportation of the Horse, has read and understands this entire Agreement, and agrees on his/her own behalf of Owner's Agent to be bound by all the terms and conditions contained therein.
